

The fourth meeting of the New York State Coordinating Council was held May 14, 1976 in Buffalo, New York. Since this meeting was held at the New York State Convention for 1976 there were many in attendance; 10 from Western New York Chapter including delegates Jerrie VanEvery (chairperson) and Joanne Fadale, Elizabeth Combs Staten Island Chapter delegate, 3 from Central New York Chapter with Linda Liddiard delegate, Adirondack Chapter delegates Zana Coates and Sandra Becker, Manhattan-Bronx Chapter delegate Liz Maunz and Chatt Chapter delegate Bonita Shaw.

Minutes of previous meeting were read with the addition that CEU credits from ANA are available for the EDNA core curriculum if the person is not certified as proficient.

Jerrie VanEvery reported that the New York State Education department is examining the cord curriculum. A grant has been approved for test development on the National level.

Election of a treasurer was held. Motion was made by Zana Coates to nominate Sandy Becker. Nomination was seconded by Liz Combs. Wandy Hackney nominated Joanne Fadale, which was seconded by Jaan Gresco. Election of Sandy Becker was by majority show of hands.

Jerrie VanEvery reported that a state level charter is necessary to qualify as a non-profit organization so this will be obtained.

HSA is requesting EDNA people to be on councils at regional levels.

Charlotte LeFean announced that our regional director may change, nothing is definite on this. She also ask that local chapter secretaries send a copy of their minutes to regional director.

Jerrie VanEvery stated that a letter would be sent by her to all New York State EDNA members stating chapter names and addresses and asking for oppinions on the 1985 proposal. She also stated that it has become necessary to ask each chapter to give one dollar per year per member to State Council funds.

Remember National Headquarters moved. The new address is 3900 Capital City Boulevard, Lansing, Michigan 48906.

Next Meeting will be in Adirondack area when Bylaws and constitution are ready.


In addition, I would appreciate a reply from you regarding the following proposal. Your positive or negative response would be of assistance.
