## NATIONAL CONFERENCE A SUCCESS

Emergency nurses took Washington DC by storm in September. The General Assembly debated multiple resolutions. Some passed with little debate while others were overhauled before the group would assent. Delegates agreed to study multistate licensure, including various

models in hopes that nurses who work interstate or who work in multiple states can do so more easily. ENA will also investigate urgent care centers, called episodic care centers, looking at standards, staffing, and whether ENA expertise could benefit these centers. Debate on whether ED nurses would work with police in alcohol drug testing of accident victims was sobering and lively wit concerns for patient privacy, advocacy, and public health all raised. ENA will study the issue further and present recommendations. ENA plans to change their organizational status in

expectation of a more favorable tax status. The Nominating Committee will become the Elections Committee, and the filling of vacancies for national officers were revised.

Jean Proehl, who ended her term as national President, recounted the previous year's achievements, and Benny Marret, inducted as President for the year 2000, outlined his vision for the year ahead. He hopes to improve communication, and reach out to more of the membership

and to involve them in ENA projects. Benny told a story of his childhood, when after dinner, he was always advised to save his fork, in anticipation of the dessert to follow. He gave attendees a fork to save, in anticipation of the good things to expect in the upcoming year.

Having concluded the general assembly, over five hundred nurses nurses lobbied on Capitol Hill, Armed with briefing material and with enthusiasm, the group advocated for a Patient Bill of Rights, COMCARE, and Prevention of Needlestick Injuries. The response to the lobbying efforts was positive. One Congressional staffer was taken aback and very impressed when told how many nurses were involved in lobbying. It was an exciting and informative day.

The Scientific Assembly was attended by

thousands interested in updating their knowledge ad skills. New York State did some recruiting and networking at a booth in the exhibit hall. NYS Council members gave out two hundred pounds of apples along with great information about New York. Thanks to Janet Curley for her efforts and to all who manned the booth.

After a long day of studying, parties were a great way to unwind and meet old and new friends.





### ISSUES AND PRACTICE COMMITTEE

Issues and Practice Committee sponsored the New York State ENA members who visited with legislators on ENA's Day on the Hill. The goal was to visit with legislators in each chapter's area. Among the issues discussed were the Patient Bill of Rights and occupational safety issues, including needlestick injuries.

The Committee has drafted and sent letters to state legislators to protect specific groups from having their health insurance canceled by HMOs because reimbursement may be low. In addition letters were also sent to local legislators to insure that hospital length of stay is determined by the patient's doctor, and not by the HMO. In following up on proposed child abuse legislation, which would require that mandated reporters have their reports in investigated, and not refused, several members will meet with Assemblyman Greene of Brooklyn, to lobby for a vote in the Assembly floor.

The nurses leading this project include Julie Briggs, Sheila Wheeler, Carol Stock, Sandra Dahl, Deb Gresham, and Sherri Smith. Valerie Grossman is the project chair.

This long awaited certification, will allow nurses who use the telephone as a significant part of their practice, to now gain board certification in this specialty area. As nurses move out of the ED/ICU/Clinic setting and into a telephone practice setting ... they have been left without an avenue to maintain their certification in their nursing area. With the creation of this exam, nurses will have the benefit of maintaining their board certification while exploring a new specialty area.

The exam is slated to be completed by mid 2000, and available to nurses by the end of 2000.


