ASSEMBLY BILL 3103

There was some buzz at the New York State Emergency Nurses Association meeting in April about Assembly Bill 3103 (A3103). What is it about? Is it important to nurses? In addition, if someone feels that it is important to nurses and their nursing practice, what can be done to support passage of legislation this term?

A3103 is legislation that "Adds Registered Nurses and Licensed Practical Nurses to assaults of emergency medical professionals and provides for (a charge of) Class C and D felonies for physical injury (to nurses)". A conviction of a class C felony in New York State carries a prison sentence of 5-15 years and a Class D felony carries a sentence of 2 1/3 - 7 years in state prison. This legislation has passed in the New York State Senate and is currently in a committee in the Assembly called Codes Committee.

A committee does the groundwork and assesses the importance of a bill before it is brought before the entire Assembly for a vote. The Codes Committee is charged with considering issues and legislation regarding the state's criminal and civil justice system. Most of the legislation in this committee amends Criminal, Penal, Civil and Executive laws and rules.

I recently spoke with John Joyce, a legislative assistant, in Assemblyman Koon's office regarding A3103. The time for passage of this bill is running out and if a citizen wants to assist in the passage of this legislation, now is the time to advocate for this bill. This year's assembly session ends in June. It is important that this bill is passed out of Codes Committee in the next few weeks, so it can be brought before the Assembly for a vote. If passed it would be sent to Governor Patterson for signature prior to the end of this year's session.

Supporting this bill would only take a few minutes of your time with a few simple steps:

1. Call/ write/ or e-mail your local Assembly person and encourage him/her to sign on to Assemblyman Koon's bill as a sponsor.
2. Include in that letter some anecdotal information about assaults on staff in your emergency department.
3. Let him/her know that this is important protection for professional nurses.
4. Contact members of the Codes Committee, especially if one of the members is representing your district, and share this information with them as well.

Finding your Assemblyperson is very easy:

1. Google New York State Assembly and click on the first entry, which is the Assembly home page.
2. Scroll down and look to the right side of the page below a box that says "ETHICS REFORM" It is labeled "Your Assemblymember". Just enter your zip code and your representative's web page will come up on the screen.

GENESEE VALLEY CHAPTER ADDRESSES EMERGENCY DEPARTMENT VIOLENCE

I feel honored to be able to bring topics of interest to the Genesee Valley Chapter of the Emergency Nurses Association (ENA). On March 10, 2010 a dinner meeting was held at the Shanghi Restaurant, which proved to be an interesting and excellent time for area nurses to network. Nurses came from as far as Clifton Springs and the Batavia area to join us. It is always exciting for me to be with nursing professionals from various hospitals.

Our guest speaker was Mr. Richard Dollinger. Mr. Dollinger served as a Monroe County legislator from 1988 to 1992. He was then elected to the NY State Senate, where he served four terms, until 2002. Mr. Dollinger is the first appointed Claims Court Judge to serve as an acting State Supreme Court Justice in the Seventh Judicial District. Mr. Dollinger is also currently teaching a Nursing law course.

Violence in the Emergency Department(ED) was the topic of the meeting. Mr. Dollinger reviewed the ENA findings on violence and noted that the types of violence and the types of patients most likely to be violent in the emergency department were not included. He also noted the lack of nurses reporting incidents of violence, as well as the over-all acceptance of violence by the nurses.

What we need to do in our departments is to define violence. What does your ED consider to be violent behavior? What kind of behavior is not tolerated in your ED?

Violence as defined by the ENA is an act of aggression directed toward persons at work or on duty that ranges from offensive or threatening to homicide. Workplace violence is commonly understood as any physical assault, emotional or verbal abuse, or threatening, harassing, or coercive behavior in the work setting that causes physical or emotional harm.

I will be discussing this with my co-workers. I will be setting up a team to assist me in working toward a non-violent work place. In my ED there will be signage placed in the department, listing behaviors that will not be tolerated, such as spitting, hitting, or harming the medical personnel providing care, and noting that violations will be prosecuted. We are implementing policies and protocols to reflect the intolerance of any violence. We also are ensuring all nurses, doctors, technicians, radiology staffs, security, administration and any other personnel with direct patient contact are on board with zero tolerance of violence in the workplace.

We, as ED team members, need to start training in de-escalation techniques to deal with violent or out of control individuals and/or stressed families. We need to involve all personnel that deal with the patient, including physicians and security. Every team member must agree that violence in the workplace is not acceptable. Each person involved in an incidence of violence must record and report the incident, what happened, what kind of patient was involved and what was done about the incident. This information must be taken to our administrators, our district attorneys and our law enforcement officers.

Did you know that in January, 2010, the NYS Senate passed a code in penal law that adds Registered Nurses and Licensed Practical Nurses to assaults of "emergency medical professionals" and provides for class C and D felonies for physical injury to them? The next step is for the NYS Assembly to pass the bill.

So I ask all nurses to write to their assemblypersons to let them know what passing this bill means to each and everyone that has ever suffered physical or verbal abuse or violence. The bill is A3103 and the web site for the assembly is <http://assembly.state.ny.us/mem/?sh=main>.

A study by the Emergency Nurses Association (ENA) found that more than one-half of emergency nurses reported experiencing physical violence on the job. One in four has experienced such violence more than 20 times in the past three years. Just as alarming, one in five nurses has experienced verbal abuse more than 200 times during the same period.

I am not just sitting back and saying that nobody cares and nobody does anything about the violence we deal with in the workplace. I am standing up and moving forward. I encourage every nurse to do the same. I invite everyone to get involved, read the studies, and gather information regarding this very important issue. A starting place would be to visit the Emergency Nurses Association website www.ena.org and look for the ENA Study on Violence against Nurses in U.S. Emergency Departments.

GINNY HENS EMS AWARDEE HELPS HAITIANS AFTER EARTHQUAKE

Thomas Sampson, who was the recipient of this year's Ginny Hens EMS Award, is a nurse at Olean General Hospital's ED. When he heard that a local pastor was organizing a medical mission trip to Haiti through World Hope International, he knew he had to say "yes."

Tom spent seven days with the mission group performing medical clinic work in the tent cities outside Port-au-Prince. The group brought donated medications and saw 765 patients in the week they were there. Tom worked in the role of a nurse practitioner, often treating patients with simple ailments on his own.

Despite the suffering and devastation, most of the Haitians still managed to have a positive outlook and were very thankful for those who came to give care, Tom said. He said the poor conditions they lived in were even worse than what was shown on television.

"It was a very rewarding experience to go there," Tom said. He encourages others to consider joining a medical mission group. "A medical aid trip is something everyone should do at least once in their life."

TNCC, ENPC and CATN UPDATES

If you have a question about TNCC, ENPC or CATNII, you can dial 1-800-942-0011 to reach the Course Operations Department directly. Please continue to use the general 800 number when you need to reach other departments within ENA, which remains 1-800-900-9659.

Twice a year Course Operations sends the State Chair a copy of the Instructor Quality Assurance reports for instructors that have scores of less than 3.0. If no instructors have a score of less than 3.0 they send an email to the State Chair advising them that all of their instructors are currently at 3.0 or higher. I urge every Course Director to review the evaluations for your courses. If you have an instructor that seems to be struggling, speak to him/her and offer suggestions to help with his/her lecture presentation and/or content. Buddy him/her with another instructor and use a team teaching approach for the skill station if that is where the low scores occur. If you need guidance with this, let me know. Don't let your students down by being inattentive to their evaluations and comments to make courses better. I recently received reports for ENPC and TNCC and am happy to report that only one instructor for each course fell below 3.0 and those scores were based on one course.

Course Operations will also email an individual instructor's report directly to that instructor upon request. You can either call Course Operations at 1-800-942-0011 or email them at courseops@ena.org to make that request.

The ENA web site is now updated on a nightly basis with all new course applications that have been processed. This information had been updated on a weekly basis prior to this change. The Course Director will receive an email confirmation the evening of the day that their course application has been processed into the system. That course will appear on the ENA web site by the following morning after receipt of the confirmation email.

To keep with the "Go Green" philosophy I ask that when you do your post-course reports do them on your computer and send them via email to me. This will save trees, postage and storage space.
