Bill Briggs, RN, MSN, CEN, FAEN (Keynote Speaker)

Briggs is the 2009 president of ENA. He is the Trauma Program Manager at Tufts Medical Center

in Boston, Massachusetts and a per diem staff nurse in the emergency department of Lowell General Hospital in Lowell, Massachusetts — a position he's held for over 22 years. In addition to his work with ENA, Briggs is a member of the Metro Boston Critical Incident Stress Management Team. He has been an instructor and instructor-trainer in first aid and home nursing for the American Red Cross and is currently an instructor for ENA's Trauma Nursing Core Course (TNCC) and Emergency Nursing Pediatric Course (ENPC).
