FEATURED SPEAKERS

DEBORAH KIRBY

Deborah Kirby received her B.S. in Nursing at SUNY Buffalo and went on to receive her law degree there in 1986. She is currently an attorney from the firm Harris, Beach, and Wilcox in Rochester, New York in the Health Services Department. Her past nursing experience is in critical care and emergency nursing, nursing education, and public health administration.

Deborah has presented numerous seminars and workshops on the law as it relates to nursing and the practice of health professions generally. Her focus has included medical records, recent legislation, law and nursing practice, financial aspects of health care provision, incident reporting, child abuse and neglect reporting requirements, documentation, and especially malpractice prevention.

Two years ago in Buffalo, Deborah was our closing speaker. At the end of her lecture many of the attendees stayed to ask more questions. Her presentation style is clear and candid.

GRADY BRAY

Grady Bray received his masters degree in vocational education and his Ph.D in Counseling Psychology from the University of Georgia. He is President of Human Potentials in Rochester, New York, a consulting business to government, health care, education and industrial organizations specializing in stress management, particularly critical incident stress and the creation of special teams for crisis intervention. Dr. Bray is also an adjunct faculty member of the National Fire Academy and National Emergency Training Center, Federal Emergency Management Agency in Emmetsburg, Maryland.

A clinical psychologist in both Georgia and New York State, Dr. Bray is internationally known as a lecturer in Critical Incident Stress and its management, and has been sent by our government to participate in and conduct Critical Incident Stress Debriefings during and following such natural disasters as earthquakes and hurricanes. He is one of the pioneers in the development of Critical Incident Stress Debriefing teams as we know them today.

As a faculty member at ENA's 20th Scientific Assembly in Chicago in 1990, Dr. Bray's presentation focused on the fact that coping with stress is an every day happening in our personal, as well as professional, lives.
