Government Affairs Committee working to advocate for NYS ED Nurses

Day on the Hill, May 20,21, 22, 2019

Day on the Hill is an annual event sponsored by national ENA where emergency nurses through out the country meet in Washington D.C. to meet with federal legislators to discuss current healthcare legislation that is before Congress and the House of Representatives. This year we sent four NYSENA council members to Washington to participate in this event. Two bills that they discussed with the legislators for support and co-sponsorship are:

Workplace Violence Prevention for Health Care and Social Service Workers Act (H.R. 1309/ S. 851)

Emergency Medical Services for Children Program Re-authorization Act (H.R. 776/ S. 1173)

As emergency nurses, our voice is strong and we must use it to facilitate change for safe practice and safe care. We encourage you to become involved. Current state council activities have focused on two current issues.

1) *Patient care protocols in the emergency room.* Many states allow for practice protocols to assist in providing patient care. Patient care protocols assist in the provision of an efficient and more streamline assessment of the patient who presents to the ER for care. In these instances, timing and immediate diagnosis is crucial for positive patient care outcomes. NYS nursing scope of practice regulations prohibit their use. Patient specific orders must be ordered by a physician, it is out of a nurse's scope of practice to do so. We are looking to address this issue.

2) *"STOP the BLEED"* campaign is a national campaign to educate the public to act in any traumatic bleeding emergency as an immediate responder to control life-threatening bleeding until EMS arrives. Although the public has been enthusiastic in learning this skill, resources may not be available to do so. NYS ENA council is seeking to change current legislation to include bleeding control kits and mandate the kits available for public access like Automatic Electronic Defibrillators.

At a quarterly state meeting, I looked around the room to find that I was the youngest member there. I don't mean by a few years either. However, I realized that many of these nurses are retired or are ADPN and are coming to these meetings to keep the chapters alive, and then I started to wonder where the nurses like me were?

Nurses are a force to be reckoned with. A Senator in Washington State learned this after a comment she made regarding our profession. We have so much passion for what we do, that we united, took a stand, and let the memes on social media begin...If we can do this in response to a comment, then this is proof that we can do so much more...

I got bitten by the ENA bug when I was a new grad in 2010. I went to my first state conference and meeting and I was hooked. I was in awe of the topics that were being discussed and the passion that the nurses from throughout NY had. I admired them. I looked up to them. I wanted to be like them. "Nobody has time because hospitals are now requiring us to have our BSN so we are all busy going back to school for that."

"I used to be a member and worked paid for it, then the funding lapsed and I didn't have the money at the time to renew and I haven't since."

"Haven't really thought about it."

"I have too many other things to focus on."

"I can't really give you a good reason."

Some chapters hold meetings at restaurants with an educational component attached to it so there is food and continuing education credit, but that still isn't enough to entice people to come. When I mentioned this so some of my nursing colleagues, their response was:

"I work nights and I don't have time to go to the meetings."

"I work days and when I get out of work I just want to shut everything off and go home."

When I look over all these reasons, I wonder how I managed to stay active all the years and travel and go to school full time as well as work in Emergency Departments all over the states. I say this not in a condescending way, but it an attempt to understand what can be done to encourage more nurses to join this organization. There are so many issues that affect how we delivery patient care and a lot of it is discussed at these meetings and we need nurses who are at the bedside to have a say.

There are so many advantages to becoming an ENA member, from scholarships and awards to research grants, to networking with nurses and potential employers.

Want to get some money to pay for school? The ENA can help with that too, with numerous scholarships to choose from.

Preserving our past..... CHATT CHAPTER

On October 10, 1975, Anna Mae Erickson, then president of the Emergency Department Nurses Association (EDNA) signed the chapter charter for the establishment of the CHATT Chapter. The most south western counties Chautauqua, Allegany and Cattaragus encompass the geographical design of this chapter.

The name CHATT was created from the letters in the name of the three counties. Originally the members were part of the Western New York chapter but due to the many months of inclement weather and the rough terrain between Buffalo and the southern portion of western New York it was

determined that the members would be best served by this new chapter. The chapter has been one of the smallest since its inception. To serve its community best, it decided that the educational offerings they would provide would be topics of interest to all Emergency Medical Service (EMS) providers. The once a year offering covered topics such as burns, orthopedics, multiple trauma and disaster management. They were very successful with 80-100 participants annually for over 10 years. The chapter attracted many occupational health nurses over the years. This resulted in a great opportunity for the emergency nurses to visit area factories to view some of the machinery that caused injuries seen in the ED's
