Faculty status. NYSENA Treasurer invited to attend committee meeting to review forms and process regarding course expenses, revenues and any other cost related items. Summary of TNCC and ENPC data:

From January - December 2025, we educated 1739 TNCC providers. $1739 \times \$25/\text{student}$ assessment from ENA = \$43,475 revenue. From January - June 2026, there are 13 ENPC courses and 48 TNCC courses scheduled. NYSENA has 65 ENPC instructors and 179 TNCC instructors.

Discussion held regarding selection/recommendations for IP status and a task force will look at this issue and provide recommendations. Teresa Burke and Coleen Vesely volunteer to work with Mary Ann on task force and to report at February meeting.
